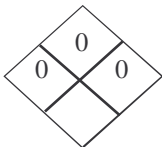

## DIRECTIONS FOR GENERAL TURF USE

Greens, Tees, Fairways, Roughs, Parks, Lawns and Sports Turf

**Use Directions:** Apply pHlocculate as a spray application , 2 treatments at 14 day intervals at the rate of 32 oz per acre. Apply sufficient water to move product into the soil profile at least 1 gallon of water per 1000 sq. ft. For soils that have high bicarbonate levels >1.5 - 2.0 meg/L or bicarbonate levels that exceed 150 ppm.

For soils that have < 150 ppm of Bicarbonates apply pHlocculate at the rate 16 to 32 oz per acre on a monthly program.
